# Polanyi Chronology M. Moleski, S.J.--Used in Nov. 2016 Polanyi Society Annual Meeting Presentation

#### 1. **Hungary** -- medicine, physical chemistry

- Born in Budapest, Hungary (*TD*, opposite title page) of Viennese parents (*Pollacsek-->Polanyi*).
- 1914 Received doctoral degree in **Medicine** from the University of Budapest
- 1914 First paper on adsorption published (*K&B*, 87).
- 1914-18 Medical officer in the Austro-Hungarian Army (K&B, 89).
- Theory of adsorption accepted as Ph.D. thesis in **Physical Chemistry** at University of Budapest thanks to the "complete ignorance of the professor of theoretical physics" (*K&B*, 93).
- 1919 Baptized a Catholic (apparently for the sake of convenience; Scott, "Religious Reality," 86).

#### 2. **Germany** -- adsorption, crystals, reaction kinetics

- 1920 Institute of Fibre Chemistry in Berlin-Dahlem (crystals, K&B, 97).
- 1923 Institute of Physical Chemistry (reaction kinetics, *K&B*, 104).
- 1929 Made Life Member of Kaiser Wilhelm Institute of Physical Chemistry (*TD*, opposite title page)
- Joint paper with London, based on quantum-mechanical resonance and "inverse third power law" (*K&B*, 90).
- 1932 **Atomic Reactions**. London: Williams and Norgate, 1932. This is a book about the simplest form of *chemical* reactions--those that take place between two atoms. It is not about *nuclear physics*, which developed later and gave us the "atomic bomb."

#### 3. England

#### A. Economics, social analysis

- Fled Hitler's persecution of the Jews. Elected professor of physical chemistry at the Victoria University of Manchester, England (*TD*, opposite title page).
- "I first met questions of philosophy when I came up against the Soviet ideology under Stalin which denied justification to the pursuit of science" (*TD*, 3). In the decade that followed, Polanyi devoted a great deal of time to **economics and social analysis.**
- 1936 **USSR Economics:** Fundamental Data, System and Spirit. Manchester University Press, 25 pp.

#### B. Philosophy, theology, aesthetics

- 1940 *The Contempt of Freedom*. London: Watts and Company, 1940.
- 1945 *Full Employment and Free Trade*. Cambridge: Cambridge University Press.
- 1946 **Science, Faith and Society**. Chicago: University of Chicago Press; "Background and Prospect" added in 1963 edition.
- Retires "from the professional pursuit of science to take up **philosophy**" (*K&B*, 87). "Manchester University has made it possible for me to accept the invitation of Aberdeen and to spend nine years almost exclusively on the preparation of this book. The generosity of Senate and Council in allowing me to exchange my Chair of Physical Chemistry for a Professorial appointment without lecturing duties . . . " (*PK*, ix).
  - "I turned to philosophy as an afterthought to my career as a scientist" (TD, 3).
- Lectures "as Visiting Professor or Senior Fellow, at the universities of Chicago, Aberdeen, Virginia, Stanford, and Merton College, Oxford" (*TD*, opposite title page).
- 1950 "Scientific Beliefs," Ethics 61 (1950) 27-37.
- "This work [Personal Knowledge] owes much to Dr. Marjorie Grene. The moment we first talked about it in Chicago in 1950 she seemed to have guessed my whole purpose, and ever since she has never ceased to help its pursuit. Setting aside her own work as a philosopher, she has devoted herself for years to the service of the present enquiry. Our discussions have catalyzed its progress at every stage and there is hardly a page that has not benefitted from her criticism. She has a share in anything that I may have achieved here" (PK, ix).

#### Polanyi's Commitment to Realism and the Reality of Ideals

Undated, unsigned. Found in a folder labeled: letters Davies (sent) from (Pol. related) 1958--> in the MP: to/from section of Bill Scott's files.

It is necessary for me, and others of my kind of convictions, to believe that **science possesses reality**; that it is discovered by man but not made by man; that it is not 'artificial' but possesses an ungovernable life of its own. Unless **such a reality, external to man's action**, is recognized, science--and truth in general, and the whole realm of intellectual and moral statements--inevitably becomes subordinate to man's material needs. There is no sense of this inevitability in people, who in T. S. Eliot's phrase, live near the Bank and the Police Station, (i.e. can rely on a steady flow of tradition, for the time being)--but to me this theoretical subordination appears as a catastrophic reality. I know the phrases in which it was formulated to persecute our fellow scientists in Soviet Russia, I recall the almost identical form of words on Hitler's and Himmler's lips when they settled on the fate of German scholars resisting their historical and anthropological theories.

I cannot rely on the mercies of common sense against logic in these matters. Your conception of reality has been recently elaborated to its final conclusion on academic grounds in **Logical Positivism**. This is a complete denial of validity in any theoretical statement. It reduces all moral, aesthetic, and religious conceptions to "ways of talking."

There seems only one way to fight, however hopelessly perhaps, for the rehabilitation of civilized thought: to secure by an act of faith the reality of our ideals. Unless we accept that position, we open, as Logical Positivism has clearly demonstrated it, the central citadel of all human convictions to the rule of nihilism. We lay down our arms and abandon any ground on which Hitler and Himmler (in their million shapes all over the world) can be resisted.

#### Addendum

Marty Moleski, S. #### Polanyi Reader

What is usually called the "Polanyi Reader," *Recovering Truth: A Comprehensive Anthology of Michael Polanyi's Writing*, by Walter Gulick (with help from others) is available for downloading at <u>polanyisociety.org</u>. This is a topically organized reader that illumines each chapter's topic with a large selection of quotations from a wide array of Polanyi's writings. More than 100 people from across the world have, in fact, inquired about the Polanyi Reader and downloaded it. A future issue of TAD will discuss the reader and include a response from Walt Gulick. A bound copy of the Polanyi Reader is available for review at the 2018 Nashotah Conference in the Polanyi materials room. Eventually, the Polanyi Reader may be turned into a cheap Amazon.com book which is printed on demand.

#### **Archival Polanyi Resources**

The 60 boxes (30 linear feet) of the Michael Polanyi Papers are in the Special Collections Research Center of the University of Chicago Library (1100 East 57<sup>th</sup> St., Chicago, IL 60637, USA). The *Guide to the Michael Polanyi Papers 1900-1975* is online at

There is a link to the *Guide* (also known as the "Cash *Guide*") on the Polanyi Society homepage at polanyisociety.org. TAD 23(1) in 1997 provides an easily printable copy of the *Guide* but 10 boxes have subsequently been added to the collection and there may have been some reorganization. The Michael Polanyi Liberal Philosophical Association (MPLPA) received a Soros Foundation grant several years ago to digitize 44 boxes of the collection. Some archival materials have been published in issues of *Polanyiana* and a database in English is posted on the MPLPA/Polanyiana site.

There are Polanyi materials in the William T. Scott archives at the University of Nevada, Reno, the Richard Gelwick archives at the University of Houston, the Doug Adams archives at the Graduate Theological Union, Berkeley, the Edward Shils Papers (in the same location at the University of Chicago as the MPP), the J. H. Oldham archives in Edinburgh University, Scotland and the John Polanyi archives at the University of Toronto. There are interesting materials in the archives of Manchester University Department of Chemistry. The Scott and Gelwick archives are not yet available; the Shils Papers and the John Polanyi archives require special permission for admission. Hillsdale College is presently considering a Polanyi collection that will, among other things, contain Martin Moleski, SJ materials and things Polanyi scholars have passed on to Phil Mullins when they retired or died.
